In the year 2018 the college has been accredited with 'B' Grade by NAAC (1<sup>st</sup> Cycle). This optimizes the high standard of education and quality research attached to this campus.

The aim of the college is to cultivate good behavior attitude and high values of life among the students. The college is a dream comes true for the Muslim women of Vaniyambadi who want to pursue higher education. Our college is situated in the prosperous leather town called Vaniyambadi, which is 65km from Vellore. At the outset our college renders yeoman service to the rural and downtrodden Society.

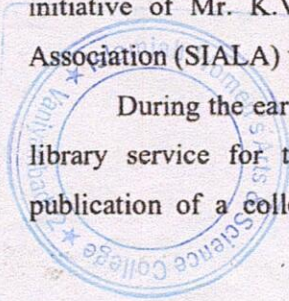
### **CENTRAL LIBRARY**

The College library was established in the formative years of the college. It has a collection of more than 18,000 books relating not only to the subjects taught in the college, but also many collections on other language. The fully computerized library functions on the basis of Open Access System in which students and staff have unlimited usage of the treasure trove. Our library has enabled with Wi-Fi connectivity. The library subscribes 26 National Research Journals, Magazines and 6 Newspaper. The college is subscribing nearly 70 lakh e-books and more than 6000 e-journals through INFLIBNET & DELNET. The library NPTEL e-learning video courses, SWAYAM PRABHA Higher Education channel, D-Space software for college Repository and Virtual library is got attached within the Central Library.

### **MADRAS LIBRARY ASSOCIATION**

Madras Library Association (MALA) was founded on 31st January 1928 by Dr. S.R. Ranganathan and Mr. K.V. KrishnanswamyAiyar. The library movement in the former Madras Presidency originated as part of the national movement for political freedom and social development. The Indian National Congress spearheaded the movement for Swaraj and its annual conferences provided a platform for other organizations with national goals to hold their meetings. The fifth All India Library Conference was held in Madras, along with the Congress session, during the last week of December 1927. As a follow up to the deliberations of this conference, through the initiative of Mr. K.V. KrishnanswamyAiyar and Dr. S.R. Ranganathan, the Madras Library Association (SIALA) was founded on 31st January 1928.

During the early years the MALA launched many innovative programmes such as a mobile library service for the rural areas of Mannargudi and Cuddalore, hospital library service; publication of a collection of essays in English and South Indian languages on the "Library

Movement" by several distinguished authors; compilation of bibliographical lists; promotion of school libraries and organizing essay competitions among school children. A programme for training librarians was started in 1929 which was handed over to the University of Madras in 1931. This later developed into a post graduate diploma course and eventually the full-fledged Bachelor's degree course.

Monographs on all aspects of library science such as Five Laws of Library Science, Colon Classification, Classified Catalogue Code and Library Administration were also published which gained international recognition. These publications form the basic works for the training programmes conducted by library schools in India and abroad. It took over two decades of perseverance on the part of MALA for the Madras Public Libraries Act to be passed in 1948. This act, the first in the country, proved to be the model for the later acts. To widen the Association's activities and concentrate on college, research and industrial libraries, the need for a permanent abode of its own was felt.

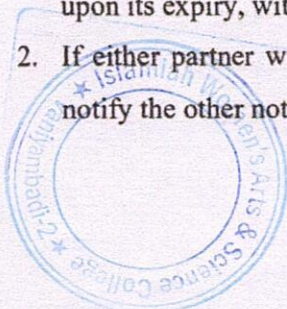
Its former president, the late S.R. Ranganathan had earmarked for the building fund a part of the proceeds of the royalties earned by his books. These funds finally provided the MALA in 1976, with premises --- a wing of the Gokhale Shastri Institute in Mylapore.



**Industrial Visit-Vanitec Ltd, Vaniyambadi**

On February 9th, 2023, a group of 61 students from II & III B.Sc Chemistry, along with three faculty members from the Department of Chemistry at Islamiah Women's Arts and Science College, Vaniyambadi, undertook an industrial visit to VANITEC LTD (Zero Liquid Discharge Common Effluent Treatment Plant ZLDCETP) in Valayampet, Vaniyambadi. The purpose of the visit was to provide students with practical exposure to industrial processes, operations, and technologies relevant to the concepts of wastewater treatment and to enhance their knowledge and understanding of industry functioning.

During the course of the industrial visit, students were explained the treatment of wastewater based on a 2-stage process comprising a Primary & Secondary treatment system. In the Primary Treatment, coarse debris and suspended solids were removed from the wastewater, and the remaining dissolved organics were degraded in a biological treatment phase using a consortium of bacteria, bringing the wastewater to a condition suitable for river discharge. Additionally, the staff members of the industry explained the implementation of the Zero Liquid Discharge System, where the Common Effluent Treatment Plant has stopped the discharge of its effluent into the river.

The industrial visit to VANITEC LTD (Zero Liquid Discharge Common Effluent Treatment Plant ZLDCETP) was a highly enriching experience for the students of our college. It offered valuable insights into industrial practices, processes, and career opportunities in the field. The visit served as a bridge between classroom learning and practical application, equipping students with valuable knowledge and skills for their future endeavors in the industry.

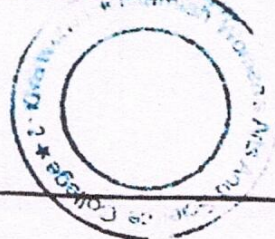
## REPORT

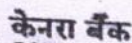

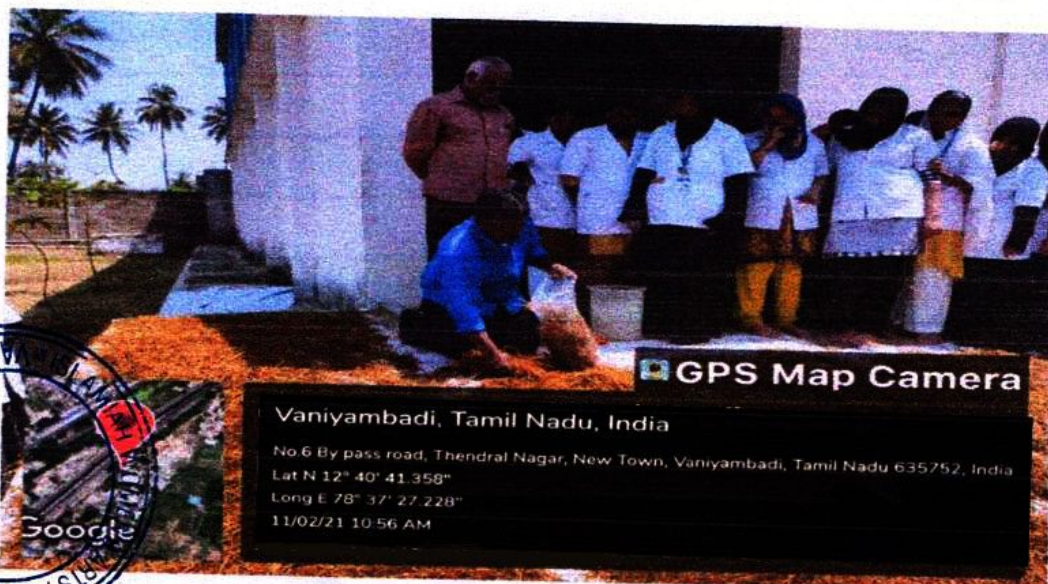

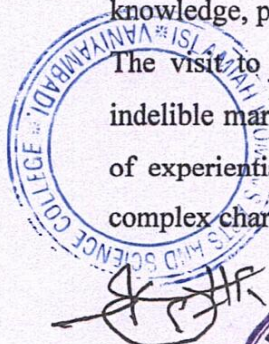

**Industrial Visit-Vanitec Ltd, Vaniyambadi**

This biological intervention played a vital role in rendering the wastewater environmentally safe, thus making it suitable for disposal into nearby rivers. It not only provided them with insightful information about industrial procedures and practices but also shed light on potential career pathways within the field of wastewater treatment and environmental engineering. By bridging the gap between theoretical knowledge acquired in classrooms and its practical application in real-world scenarios, the visit equipped students with invaluable skills and knowledge, priming them for future endeavors in the realm of chemistry and allied industries. 
### **SOFT SKILL TRAINING PROGRAM ON "COMMUNICATION & PROFESSIONAL SKILLS"**

#### **REPORT**


**DATE : 24.02.2019 TO 04.03.2019**

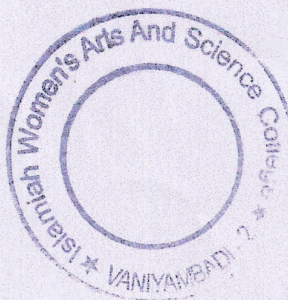
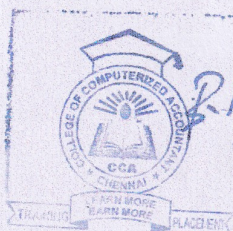
