Anti-Ragging Policy

In Compliance with UGC Regulations

Islamiah Women's Arts and Science College strictly adheres to the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009, and the Second Amendment, 2013. Ragging in any form is strictly prohibited and punishable under the law.

The institution has adopted a **zero-tolerance policy** toward ragging and is committed to maintaining a campus environment that fosters respect, dignity, and safety for all students.

What Constitutes Ragging?

As per UGC Regulations, **ragging includes:**

- Any conduct by a student or group of students that causes physical or psychological harm, discomfort, or fear.
- Teasing, abusing, mocking, or playing practical jokes on another student.
- Forcing students to perform acts that they would not do voluntarily.
- Any behavior that violates a student's dignity or invades their privacy.

UGC's Directive

The UGC mandates that:

- **Ragging is a criminal offense.**
- Institutions must take immediate action on any complaints.
- Students and guardians must submit **anti-ragging affidavits** at the time of admission.

Anti-Ragging Committee

To oversee and enforce anti-ragging measures, Islamiah Women's Arts and Science College has constituted the following statutory bodies:

- Preventive patrolling
- Immediate response to incidents



Punishable Acts and Penalties

Punishment for those found guilty of ragging may include:

- Suspension or expulsion
 - Debarring from exams
 - Withholding of scholarships
 - FIR filing and criminal prosecution under the Indian Penal Code
 - Other disciplinary actions as deemed fit by the Anti-Ragging Committee
